
Description of this fund

The Carbon Fund's investment objective is to provide investors with a total return exposure to movements in the price of carbon credits. The Fund has the ability to buy carbon credits in emissions trading schemes in New Zealand and offshore. As a result, the Fund may also provide exposure to the price of carbon offshore. The Fund targets a position of being fully hedged to the New Zealand dollar.

What are the risks of investing?

Risk indicator for the Carbon Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Sam had \$10,000 in the fund at the date the fund started and did not make any further contributions. At the end of the year, Sam received a return after fund charges were deducted of \$1,528 (that is 15.28% of his initial \$10,000). Sam did not pay any other charges. This gives Sam a total return after tax of \$1,528 for the year.
