# Quarterly Fund Update: Carbon Fund – 31 March 2020


This fund update was first made publicly available on 1 May 2020.

# What is the purpose of this update?


## Description of this fund

The Carbon Fund's investment objective is to provide investors with a total return exposure to movements in the price of carbon credits. The Fund has the ability to buy carbon credits in emissions trading schemes in New Zealand and offshore. As a result, the Fund may also provide exposure to the price of carbon offshore.



#### What are the risks of investing?

#### Risk indicator for the Carbon Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



## Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Sam had \$10,000 in the fund at the date the fund started and did not make any further contributions. At the end of the year, Sam incurred a loss after fund charges were deducted of \$574 (that is -5.74% of his initial \$10,000). Sam did not pay any other charges. This gives Sam a total loss after tax of \$574 for the year.
